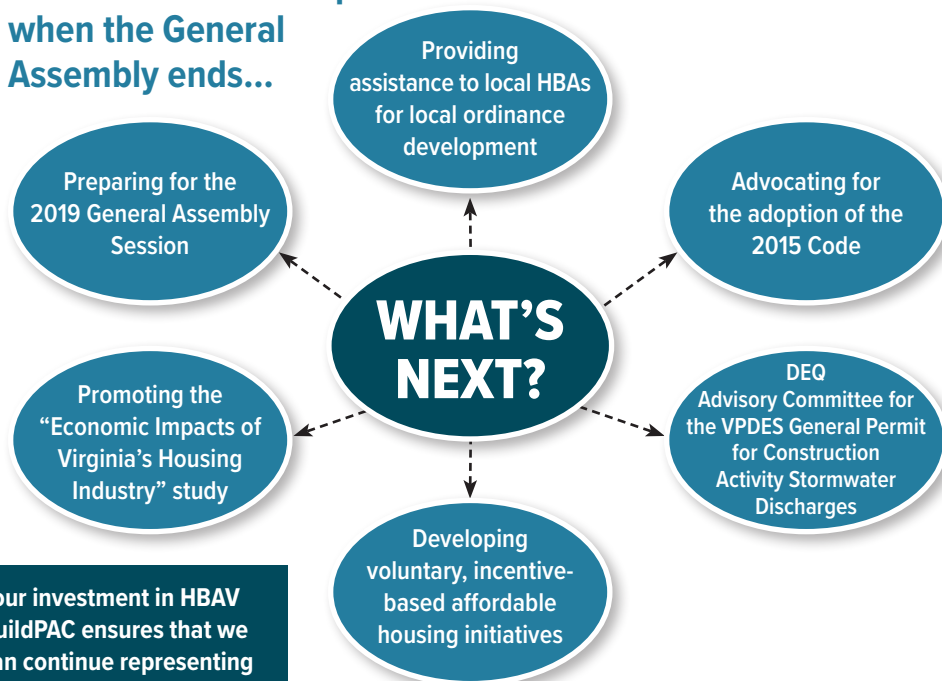




With your support during the 2018 General Assembly Session, HBAV was able to...
